WOODMERE VILLAGE REGULAR COUNCIL MEETING MINUTES OF DECEMBER 9, 2015

CALL TO ORDER: The Woodmere Village Regular Council Meeting of December 9, 2015 was called to order by Council President Benjamin I. Holbert, III at 7:20 PM.

ROLL CALL: The Roll was called by Clerk of Council Sheryl C. Blakemore.

MOTION TO EXCUSE ANY ABSENT COUNCIL MEMBER(S): No motion was made.

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was recited in unison led by Officer Luis Rodriguez.

MINUTES: A MOTION was made [Miller, Brockwell] to ADOPT the Woodmere Village Regular Council Meeting Minutes of November 11, 2015. The Motion PASSED by a 6/0 vote.

MEETING OPEN TO THE PUBLIC (Limited to items on the Agenda and a time limit of three minutes):

There were no comments from the public at this time. Council President Holbert acknowledged the re-election of Councilwoman Earley, Councilman Adams, himself and the election of Mrs. Alberta Fanning to Council. He also mourned the passing of long-time resident Manuel Curry. The Mayor issued a Proclamation mourning Mr. Curry's death.

FOR THE PERIOD JANUARY 1, 2015 THROUGH DECEMBER 31, 2017, FOR THE PATROL OFFICER BARGAINING UNIT AND THE SERGEANT AND LIEUTENANT BARGAINING UNIT, AND DECLARING AN EMERGENCY.

A MOTION was made [Earley, Brockwell] to **PASS THIS RESOLUTION BY EMERGENCY.** The Motion **PASSED** by a 6/0 vote.

A **MOTION** was made [Miller, Brockwell] to AUTHORIZE AXA EQUI-VEST, EFFECTIVE JANUARY 1, 2016 TO OFFER VILLAGE EMPLOYEES, INCLUDING ELECTED OFFICIALS, THE OPPORTUNITY TO PARTICIPATE IN ITS 457 DEFERRED COMPENSATION PLAN IN ACCORDANCE WITH THE RULES AND REGULATIONS ESTABLISHED BY THE IRS FOR 457 DEFERRED COMPENSATION PLANS. The Motion **PASSED** by a 6/0 vote.

A **MOTION** was made [Miller, Wade] to APPROVE THE WOODMERE VILLAGE NOVEMBER, 2015 EXPENDITURES AS RECOMMENDED BY THE FINANCE COMMITTEE. The Motion **PASSED** by a 6/0 vote.

REPORTS OF THE DEPARTMENTS:

<u>Mayor Smith:</u> The Mayor thanked Council for all their hard work during 2015. Some highlights from his report: Woodmere's legal profile has been lowered; the Police and Fire and Service Departments are greatly improved; the new Service Center construction will begin soon; Woodmere has hired someone to market our brand.

Law Director Consolo: No report. He thanked Council for his reappointment.

<u>Treasurer Cornhoff:</u> He submitted a written report that includes updated Finance reports. He thanked Council for his reappointment and wished everyone a Happy Holiday.

Police Chief Mason: She submitted a report in writing. Unused/unneeded equipment will be going on the Gov.deal website. A documentary on the morale of the Department will be on Woodmere's website beginning December 21, 2015. She wished everyone a Happy Holiday. **Building Inspector McLaughlin:** Absent, no report.

<u>Clerk of Council Blakemore:</u> She is working on the 4th quarterly report. A letter was received from the Department of Commerce, Division of Liquor Control stating that beginning on September 29, 2015 an on-premises liquor permit holder may file an application with the Village seeking to extend the hours in which it may sell alcoholic beverages during a "qualified major event". Chipotle Restaurant is transferring a liquor permit from a Cleveland Heights location to the restaurant in Woodmere.

Architectural Review Board: No meeting.

<u>Fire Chief Brewington:</u> He submitted a written report. He stated that for safety, all buildings should have visible addresses displayed.

<u>Acting Director of Public Service Miller:</u> He stated that he had enjoyed working with everyone during 2015 and wished everyone a Happy Holiday.

Planning and Zoning Representative Adams: New signs are in place for A T & T. He also stated that all buildings should have addresses prominently displayed. He thanked Council for their work supporting the Planning and Zoning Commission during 2015.

Marketing Director Malone: She listed some progress that has been made to "brand" Woodmere Village: She attended the RNC hotel forum; there will be 350 coach buses to transport conference attendees; perhaps Woodmere should appoint a spokesperson to represent the Village in media communications; make sure that Woodmere has undergone a beautification process wherever necessary; hotels are currently booked as far away as Ashtabula; radio spots have appeared on I (heart) Radio and WMJI.

<u>Utilities (Adams):</u> Some items for discussion: traffic signals, application for a grant, widening of Brainard and the Woodmere Village TV station.

<u>Legislation (Holbert)</u>: Committee items are reflected in tonight's Agenda. Councilwoman Brockwell has been appointed transportation director for Beachwood Schools. The swearing-in ceremony will be held on January 3, 2016 at 4:15 PM. The Organizational Meeting will be held on January 6, 2016 at 6PM. Council President Holbert thanked Councilman Singh for his service to Woodmere Village. Council electees must turn in a financial report to the Board of Elections by Friday.

NEW BUSINESS: Councilwoman Earley suggested that we take advantage of our membership in the National League of Cities. Council President Holbert stated that we might want to participate in the Leadership Cleveland program.

Mrs. Alberta Fanning asked how many liquor permits are in the Village of Woodmere. The Law Director stated that none are available at this time. A business would have to transfer one in from another municipality.
