



PUBLIC NOTICE

Pursuant to Sections 105.03 and 121.02 of the Codified Ordinances of the Village of Woodmere notice is hereby given that a Special Meeting of the Council of the Village of Woodmere is called by the Council President to take place on Tuesday, September 6, 2022 at 6:00 pm in the Village Hall Council Chambers, 27899 Chagrin Boulevard, Woodmere Village, Ohio.

The purposes of the Special Meeting are as follows:

1. Consideration of ORDINANCE NO. 2022-50: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE I TO CHANGE THE DESCRIPTION OF THE VILLAGE'S NAMES AND BOUNDARIES; AND DECLARING AN EMERGENCY.
2. Consideration of ORDINANCE NO. 2022-51: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE III, SECTION III-2 TO CHANGE THE QUALIFICATIONS OF COUNCILMEMBERS AND THE MAYOR TO PROHIBIT FAMILY MEMBERS FROM SERVING ON COUNCIL TOGETHER OR AS MAYOR; TO PROHIBIT THE COUNCIL FROM VOTING ON CONTRACTS CONCERNING FAMILY MEMBERS; TO PROHIBIT THE ADMINISTRATION FROM HIRING OR APPOINTING FAMILY MEMBERS; AND TO CHANGE THE RESPONSIBILITIES OF NEWLY ELECTED COUNCILMEMBERS; AND DECLARING AN EMERGENCY.
3. Consideration of ORDINANCE NO. 2022-52: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE III, SECTION III-3 TO REQUIRE THAT COUNCILMEMBERS WHO CHAIR A STANDING COMMITTEE HOLD A PUBLIC MEETING QUARTERLY; DECLARING AN EMERGENCY.
4. Consideration of ORDINANCE NO. 2022-53: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE III TO ADD SECTION III-10 TO PROVIDE THAT THREE (3) CONSECUTIVE UNAPPROVED ABSENCES OF A COUNCILMEMBER FROM REGULAR COUNCIL MEETINGS, OR SIX (6) UNAPPROVED ABSENCES DURING A TERM, OPERATES TO VACATE SUCH COUNCILMEMBER'S OFFICE; AND DECLARING AN EMERGENCY.

5. Consideration of ORDINANCE NO. 2022-54: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE IV, SECTION IV-1 TO ALLOW THE MAYOR TO HOLD OFFICE AGAIN AFTER A FOUR-YEAR ABSENCE; AND DECLARING AN EMERGENCY.
6. Consideration of ORDINANCE NO. 2022-55: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE IV, SECTION IV-2 TO PROVIDE THAT THE FAILURE OF THE MAYOR TO BE QUALIFIED FOR OFFICE SHALL NOT RENDER VOID OR INEFFECTIVE ANY ACTION IN WHICH THE MAYOR PARTICIPATED WHEN HE OR SHE WAS QUALIFIED TO SERVE AS MAYOR; AND DECLARING AN EMERGENCY.
7. Consideration of ORDINANCE NO. 2022-56: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE IV, SECTION IV-7 TO PROVIDE THAT THE COUNCIL PRESIDENT DOES NOT BECOME ACTING MAYOR UPON THE MAYOR BEING ABSENT FROM THE VILLAGE BUT ONLY UPON THE MAYOR BEING TEMPORARILY INACCESSIBLE AND UNABLE TO PERFORM HIS OR HER DUTIES; AND DECLARING AN EMERGENCY.
8. Consideration of ORDINANCE NO. 2022-57: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE IV, SECTION IV-8 TO CHANGE THE TIME PERIOD DURING WHICH THE MAYOR IS UNABLE TO PERFORM HIS OR HER DUTIES, BEFORE COUNCIL MAY DECLARE THE OFFICE OF MAYOR VACANT, FROM SIXTY (60) TO NINETY (90) DAYS; AND DECLARING AN EMERGENCY.
9. Consideration of ORDINANCE NO. 2022-58: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE IV OF THE VILLAGE CHARTER TO ADD SECTION IV-10 PROVIDING THAT A FULL-TIME MAYOR SHALL BE THE HIGHEST COMPENSATED EXECUTIVE OFFICER OF THE CITY BASED OFF OF THE ADMINISTRATION SECTION OF AMENDED SALARY ORDINANCE NO. 2022-39; AND DECLARING AN EMERGENCY.
10. Consideration of ORDINANCE NO. 2022-59: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING ARTICLE V OF THE VILLAGE CHARTER TO ADD SECTION V-9 TO PROVIDE PROCEDURES FOR THE REZONING OF LAND FROM U1 SINGLE FAMILY RESIDENTIAL CLASSIFICATION TO ANOTHER CLASSIFICATION; AND DECLARING AN EMERGENCY.
11. Consideration of ORDINANCE NO. 2022-60: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING ARTICLE V OF THE VILLAGE CHARTER TO ADD SECTION V-10 TO PROVIDE PROCEDURES FOR SUBMISSION TO THE ELECTORATE THE QUESTION OF RECLASSIFYING OF LAND FROM U1 SINGLE FAMILY RESIDENTIAL ZONING TO ANOTHER ZONING CLASSIFICATION; AND DECLARING AN EMERGENCY.

12. Consideration of ORDINANCE NO. 2022-61: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE VII, SECTION VII-2 TO REMOVE MASCULINE PRONOUNS AND MAKE THE SECTION GENDER NEUTRAL; AND DECLARING AN EMERGENCY.
13. Consideration of ORDINANCE NO. 2022-62: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE VIII, SECTION VIII-2 TO CHANGE THE PROCEDURES AND PROVISIONS FOR THE RECALL OF ELECTED OFFICIALS; AND DECLARING AN EMERGENCY.
14. Consideration of ORDINANCE NO. 2022-63: AN ORDINANCE TO SUBMIT TO THE ELECTORS OF THE VILLAGE OF WOODMERE THE QUESTION OF AMENDING THE CHARTER AT ARTICLE XI, SECTION XI-2 TO PROVIDE FOR THE APPOINTMENT OF CHARTER REVIEW COMMISSION MEMBERS AND THE PROCEDURES FOR REVIEWING THE CHARTER; AND DECLARING AN EMERGENCY.
